# Excess deaths in Alberta surge past 10,000 - evidence of government cover-up (Part 2)

Alberta Premier Jason Kenney must have thought he was going to be a hero. The Alberta government introduced the "vaccine outcomes" section on its website on June 3, 2021, showing 93% vaccine effectiveness for Moderna and 90% for Pfizer (<u>click here</u>).

You could see the data was presented in such a way as to make the single vaccinated WANT to get their 2nd jab (using words like "partial vaccination" and "require two doses":

(a) Vaccine effectiveness estimates include 95% confidence intervals (CI) and describes the protection against symptomatic infection. Vaccine effectiveness for hospitalization and death could have different estimates.

(b) Vaccine effectiveness estimates for AstraZeneca/other products and emerging variants are not provided due to limited sample sizes, which make estimates unstable and difficult to interpret. Information on other vaccine products and variants will be provided when estimates become stable

(c) Partial vaccination: people are considered partially vaccinated 14 days after their first dose of a two dose series (for vaccines that require two doses)

(d) Effectiveness: how well a vaccine prevents the outcome of interest in the real world

On July 22, 2021, Alberta government added information on the "other clot shot": AstraZeneca - 88% effective! (<u>click here</u>)






# Tripling down with booster shots....and it works...for a bit

But AHS and Public Health pressed on with COVID-19 booster shots, and it seemed to work, at least initially....





## **COVID-19 Booster shot failure in Alberta...**

I started talking about COVID-19 booster failure in Israel on Twitter in August 2021 (until Twitter restores my account and all my posts, you have to take my word for it).



It's not like the evidence was hard to find. There is even a New York Times August 18, 2021 article titled: "Israel, once the model for beating Covid, faces new surge of infections... Israel now has one of the highest infection rates in the world, **raising questions about the vaccine's efficacy**". (click here). In October 2021, Israeli Health Authorities admitted that almost all the deaths were in the vaccinated and that the booster shots were causing "immuno…erosion", in a video that is now difficult to find (<u>click here</u>).

Yet, it seems Alberta's grossly incompetent health leaders didn't pay attention to Israel's obvious COVID-19 mRNA booster failure, which was known to every competent doctor and scientist around the world as of August 2021.

Looking in hindsight, the COVID-19 booster shot in Alberta started to fail on January 31, 2022, and failed completely around February 15, 2022, although Alberta's mainstream media never reported it.




The "protection" of the booster shot apparently lasted only two months. By January 31, 2022 the unvaccinated were doing better than the triple vaccinated and by February 15, 2022, the triple vaccinated took the lead from the poor double vaccinated, in having the highest COVID-19 case rate of any group of Albertans (above left).

But Alberta was coming out of the big Omicron wave, so the Alberta government ignored the obvious failure of the 1st COVID-19 booster shot, as cases were falling across the board.

March 22, 2022 was the last time the Alberta government would ever put out this graph (look above to the right). The triple vaccinated case rate, which was the worst of any group of Alberta, started to rise again, into what would become COVID Wave #6.

Someone in the government knew that a new COVID-19 wave was coming and it would be led by the triple vaccinated, who were already doing worse than the double vaccinated (who themselves were absolutely devastated in wave #5 in Jan 2022).

On March 23, 2022, just as COVID-19 wave #6 started, led by the triple vaccinated, the Alberta government removed these case rate graphs by vaccination status from their website. Permanently.



COVID-19 Wave 6 lasted from March 19, 2022 until June 24, 2022. On March 19, 2022, the triple vaccinated made up 33% of the hospitalizations, and by June 24, 2022, the triple vaccinated made up 52% of the hospitalizations. This was a "pandemic of the triple vaccinated".



Thanks for laying this all bare in an easy to parse manner, Dr Makis. I was writing about these stats to Jason Kenney and Jason Copping pretty regularly, by email, from late 21 through mid

22, never getting replies. Then lo and behold, I got this reply from Copping, dated July 11/22:

"Thank you for your emails to Premier Kenney and me regarding COVID-19 vaccines. As Minister of Health, I appreciate the opportunity to respond on behalf of the Government of Alberta.

Current available evidence does indicate that COVID-19 vaccine protection against infection by the Omicron variant is generally lower than it was against previous strains of the virus; however, protection against severe outcomes, like hospitalization and death, remain strong, particularly after a booster dose. Detailed information can be found at <u>alberta.ca/vaccine</u>; scroll to "About the Vaccines" and select "Vaccine Effectiveness against Omicron".

With respect to hospitalization data for individuals with COVID-19, it is important to look at the number of Albertans in each of the vaccinated and unvaccinated groups, and consider the proportion of individuals who were hospitalized from each group. You may be interested to know that hospitalization rates, in fact, continue to be higher among unvaccinated individuals compared to those who are fully vaccinated and those who have received a booster dose.
