On January 27, 2024 at 1446 hours, Amrit BIRRING and a group of people attended the Surrey RCMP Main Detachment to protest and to lodged a complaint against the BC Education Minister and Surrey MLA, Rachna SINGH. BIRRING is a member of the Anti-SOGI (Sexual Orientation and Gender Identity) group. BIRRING provided an audio statement in which he stated that SINGH and the Surrey School Board have committed a crime by allowing sexually explicit materials to be available in Elementary and High Schools in Surrey. BIRRING stated that there are two books that are currently available in Surrey Schools that contain sexually explicit images. BIRRING provided the name of the two books as " It's Perfectly Normal" and "Gender Queer". BIRRING showed pages from both books that depicted images of what appeared to be same sex couple engaged in sexual acts. BIRRING finds this is unacceptable as these books should not be accessible to children in schools. BIRRING stated that he attended SINGH's office to speak with her directly but he was dismissed. BIRRING also wrote a letter to the Surrey School Board and they replied by confirming that the two books are available in some schools for educational purpose and to promote sexual diversity and be inclusive. BIRRING would like police to investigate as he finds these books to be inappropriate for school aged children. Cst BOATENG met with the Surrey School Board to discuss the concerns. Cst BOATENG learnt from the School Board that the books are there for Educational purpose and it's also to promote diversity and inclusion in the school system. The School Board also confirmed that these books are not part of the school's curriculum; they are in the school's library for students to use as resources if needed. BIRRING updated. No further action.

On February 20, 2024, Cst BOATENG attended the Surrey School located at 14033 92 Ave and met [REDACTED] who is the Director of Instructions. Cst BOATENG discussed the complaints made by BIRRING, who a member of the Anti-SOGI group. Specifically, Cst BOATENG informed [REDACTED] that BIRRING had lodged a police complaint with regarding what he deemed to be inappropriate materials being shown to children in schools in Surrey. BIRRING believes that two books in-particular, that are being in some schools in Surrey, do contain sexually explicit images not suitable for children. BIRRING provided the names of the two books in question as " Gender Queer" and "It's Perfectly Normal"

[REDACTED] that the Surrey School district is aware of BIRRING and the Anti-SOGI group. The group and it's members have attended numerous school board meetings and have brought up similar concerns in which the School Board has replied to each of their concerns via mail. [REDACTED] BIRRING via mail and have addressed the Surrey School Boards rationale for having these two books in some of Surrey Schools. [REDACTED] that the two books that BIRRING complained about were carefully examined and reviewed prior to them being allowed into the school system. [REDACTED] the two books in question are not being forced onto students to read and nor are the books being used as part of the curriculum. The two books are there as resources for students and family to have access to when needed. The books could be accessed through the school's library by way of self selection and in fact, these books have not even been checked out once since they've had it. [REDACTED] one of the goals for the Surrey School Board is to promote and encourage diversity and inclusion within the school system. The Surrey School Board is aware that there are parents and families who may not agree with some of the books that are in the school system but these books are only there for educational purpose to help students that are going through crisis or experiencing different things in their lives.

On January 28, 2024 at 1507 hours, Cst BOATENG obtained an audio and video recorded statement from Amrit BIRRRING and he in part stated the following:

- Amrit advised that he wanted to lodged a complaint against Rachna SINGH, who is the BC Minister of Education and Surrey MLA;
- Amrit advised that SINGH has approved two books to be used in Elementary and Secondary School Libraries;
- The two books that have been approved are "It's Perfectly Normal" and "Gender Queer";
- Amrit stated that these two books contain sexually explicit images and should not be used in Elementary and High Schools in BC;
- Amrit stated that he sent a letter to the Surrey School regarding these two books and they confirmed that these books are available at some of the Elementary and High Schools in Surrey;
- Amrit stated that Surrey Schools rationale for having these two books were for educational purposes and to promote gender and sexual inclusiveness;
- Amrit stated that him and his group have attended SINGH's office in Surrey but there were ignored and escorted off the property;
- Amrit believed that having these two books available and accessible to school aged children is a criminal offence under Section 171.1;
- Amrit would like police to investigate this complaint;
